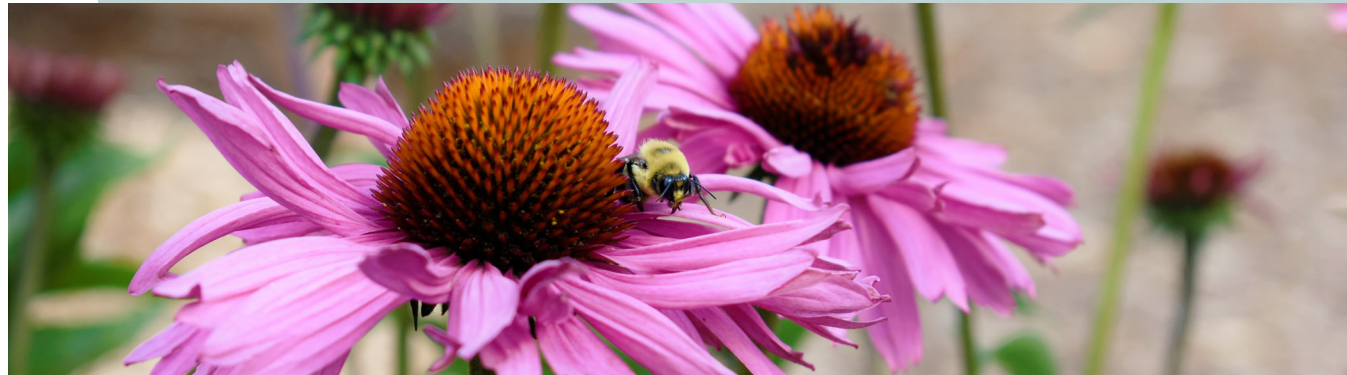

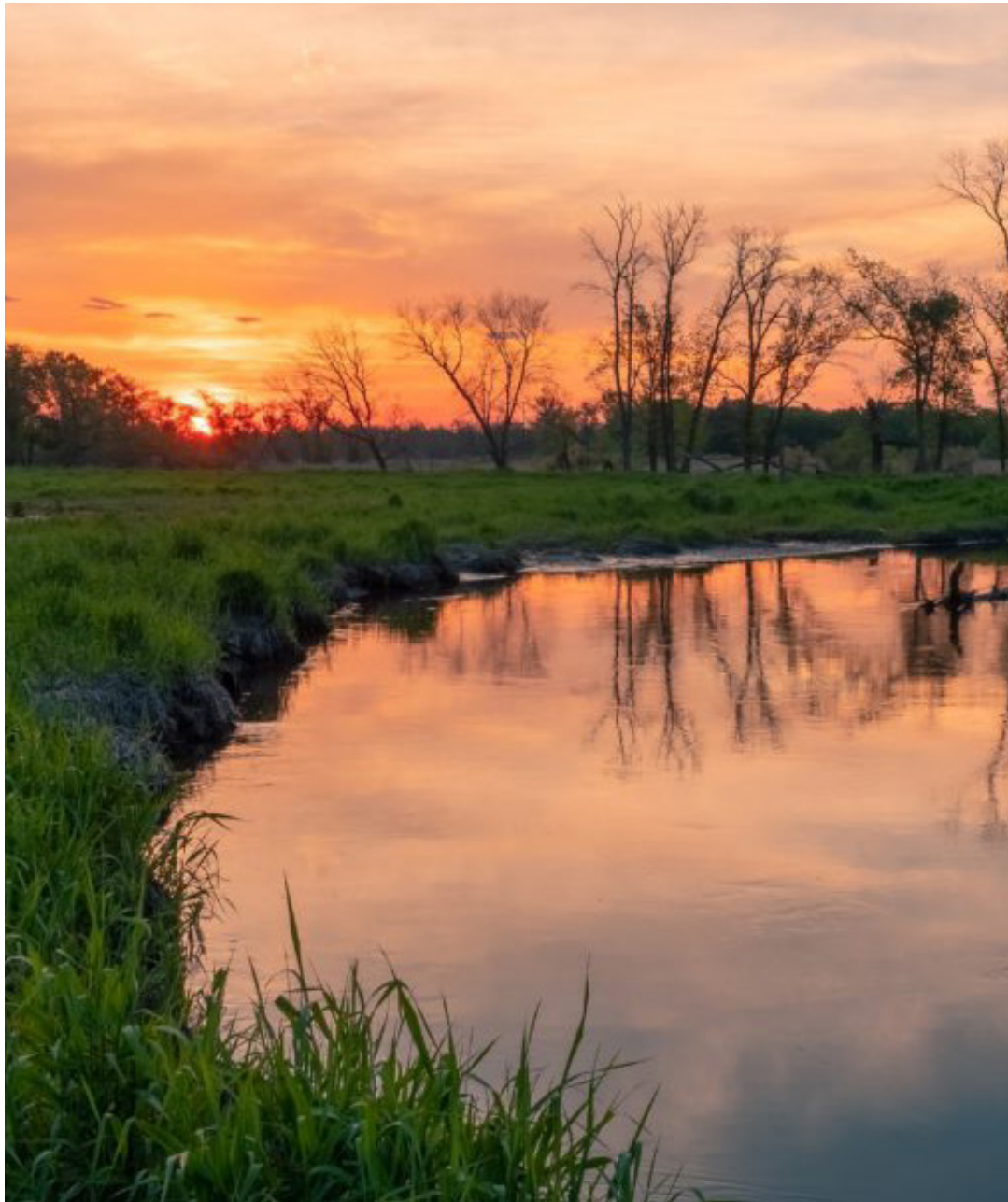
DONOR RECOGNITION

For more than two decades, the Great Outdoors Foundation has served as a leader in conservation and outdoor recreation. 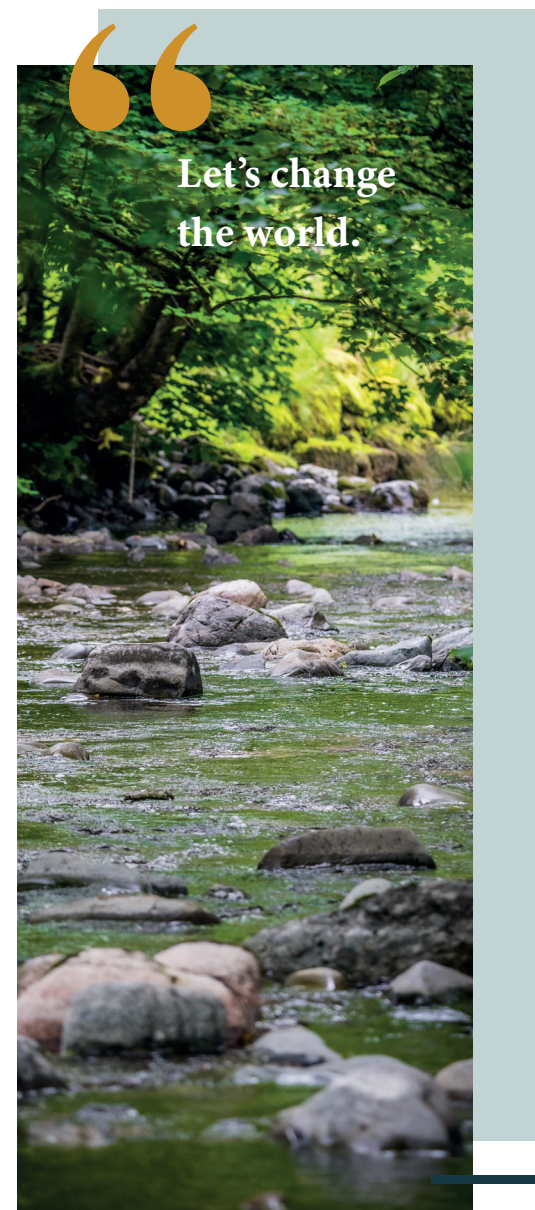
Already, we are integrating our strategy with agricultural stakeholders upstream and assessing barriers to change that, when addressed, will unlock a way forward that not only satisfies the economic incentives of our agriculturally-driven state, but also safeguards our water, land, and other natural resources for future generations. We see ourselves positioned to connect all of the existing components — conservation best practices, existing government funding, private dollars from socially conscious businesses, and farmers and landowners — to move the needle on water quality in a calculable way.

We are pioneering a way forward that brings all parties to the table and implements the infrastructure needed to funnel capital into targeted tributaries, communities, and watersheds. Our proprietary system isn't an additive; it's a multiplier. Over the last three years, the Great Outdoors Foundation has invested more than \$200 million in conservation and outdoor recreation. In another three years, I'm confident that amount won't just double, it will be exponentially leveraged and invested in our most precious resources.

If we want to do what has never been done, we have to go where no one has ever gone. The Conservation Fund is the first of its kind, and we're stepping into the new role of conservation venture capitalist as we manage a portfolio of projects and initiatives that provide a quantifiable return on investment for those who choose to partner in our vision. I am grateful to you, to our hundreds of faithful donors, and to our dozens of ally organizations who not only believe in our mission but are trailblazing right alongside us. If there is one thing I know from my years with the Great Outdoors Foundation it's that there is only one way forward: together.

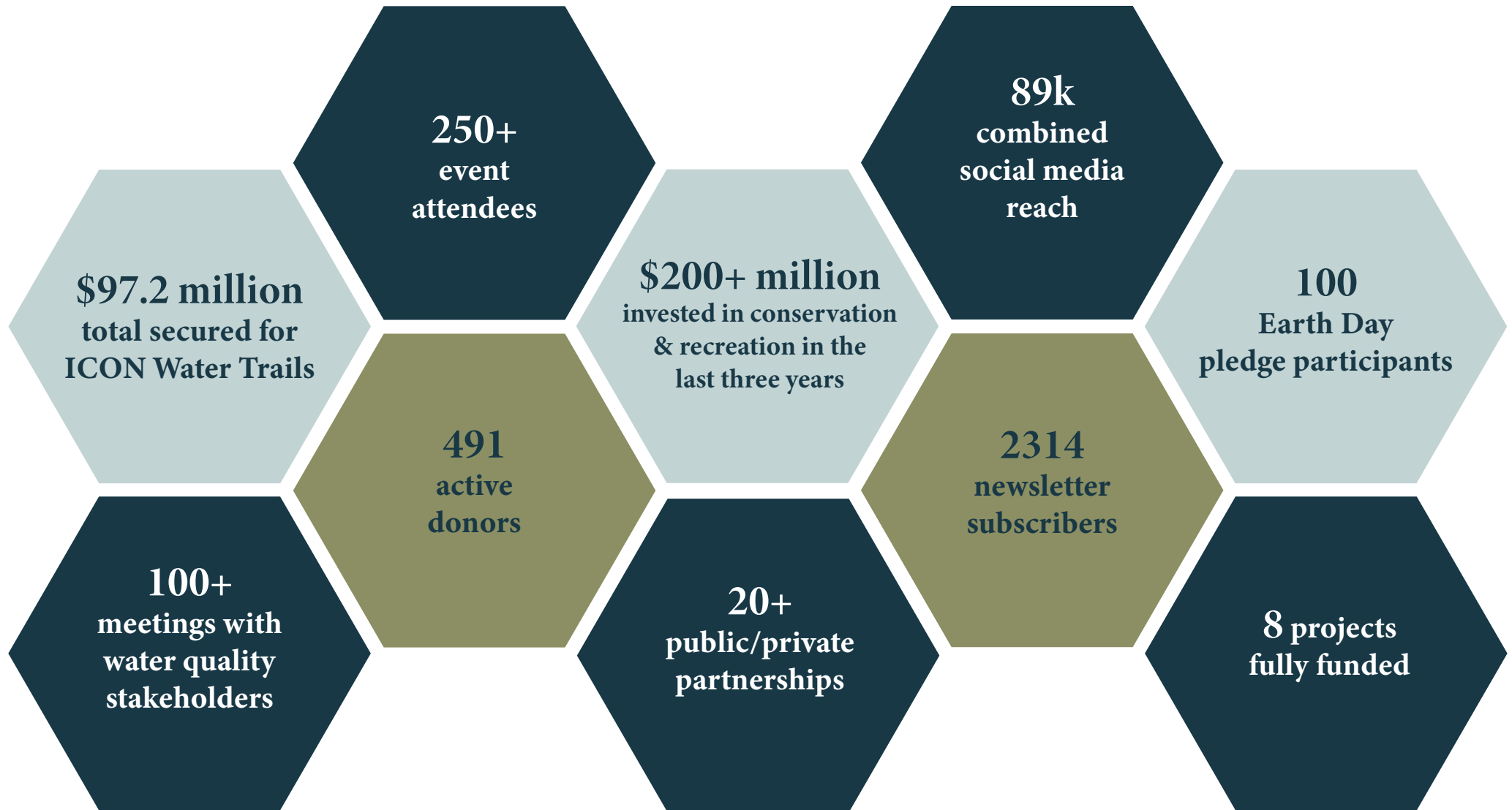
